

INDUSTRIAL VACUUM CLEANER SYSTEMS PNEUMATIC (AIR-OPERATED) MODEL AVSD-14 - HEPA FILTRATION AVAILABLE STATIC DISSIPATIVE/GROUNDED





- In accordance with ATEX 100a, Directive 94/9 EC for Category 2 Zone 1-2 (Gas) and Zone 21- 22 (Dust) hazardous locations, for non-electrical equipment.
- This vacuum cleaner system, along with its accessories, is grounded to ensure static dissipation during use. Please make sure that the air supply hose *SD is attached to a grounded air supply.
- The model AVSD-14 is equipped with a 6mm venturi jet. 5mm and 7mm venturi jets are available upon request to better suit specific compressed air availability and to provide the best performance for each application (vacuum vs airflow.)
- Uses a venturi system to transform compressed air into powerful suction without the use of electricity. Tiger-Vac's venturi system has no moving parts and generates no heat for trouble free operation without wear.
- Powerful suction Designed for industrial applications.
- Made of stainless steel with grounded suction intake.
- Disposable Paper Filter Bags (litres)

Warning:

This appliance is a wet & dry recovery, compressed air vacuum cleaner and is designed for use in four different environments:

- To pick up non-explosive dust and debris in an unzoned atmosphere (no risk of static spark or explosion.)
- To pick up non-explosive dust and debris in Zone 1 (Gas) and Zone 21 (Dust) atmospheres. Zone 1 (Gas) areas are classified areas in which an explosive atmosphere consisting of a mixture with air or flammable substances in the form of gas, vapour or mist is likely to occur in normal operations occassionally.
- To pick up combustible dust or debris that generates static and/or may also explode if ignited by a static spark in an unzoned atmosphere, with the exception of metallic dusts
- To pick up combustible dusts or debris that generates static and/or may explode if ignited by a static spark in a potentially explosive atmosphere classified ATEX Zone 22 for Dust, with the exception of metallic dusts.

AVSD-14 industrial vacuum cleaner system can be used in areas where solvents and flammable liquids are present but <u>CANNOT BE USED TO RECOVER SOLVENTS AND FLAMMABLE LIQUIDS</u>.


